The Clerk reported that it had been identified that the Welsh Ambulance Service has produced signage for the type of telephone kiosks which have been used for this installation. **Resolved** that Cllr N Holman will investigate the availability of the signage and also speak to the Welsh Ambulance Service to ascertain if codes have been provided for the boxes.

### **Minute no. 23 – PACT – Policing Matters**

**Resolved** to remove from the agenda reference to the PACT meetings as these have since stopped. The Clerk was instructed to send the Police an invitation to attend at the next Council meeting.

### **Minute no. 24 – Cross Hands Park**

The Clerk provided a report on recent incidents of vandalism at the park. It appears that the park is being regularly used as a meeting place for teenagers where they eat takeaway meals and drinks which causes a significant litter problem. There have been a few incidents of vandalism which have required significant work by the Council caretakers. This was noted with concern by the Councillors.

### **Minute no. 28 – Adverse Possession CYM 757751**

The Clerk provided a report on discussions with the applicant who has submitted a claim for adverse possession of the land at the rear of 19 Bethesda Road, Tumble. It was **resolved** that the Council wishes to proceed with the transfer of the land on behalf of the community and will cover any costs in relation to the transaction. The Clerk was requested to make contact with the owners of the site advising them of this interest.

### **Minute no. 29 – CDO Report**

The CDO provided an overview on her previously circulated report. The following matters were considered:

#### Wellbeing Annual Report

It was noted that a copy of the draft Wellbeing Annual Report has been circulated to all members for consultation. It was agreed that a meeting of the Annual Report working group will be convened on May 21<sup>st</sup>. Further agreed that a Personnel Committee will be convened to follow on the same evening.

#### Pride in Your Garden

It was reported that the competition is being organised again with the deadline for entries being the end of June.

#### Skateboard Park Development

It was reported that the RIOT group has expressed concerns that there is no progress being made with this project and there is a risk that the project can fail if members of the group lose interest due to inactivity. It was agreed that there is a need for the scheme to be progressed with some urgency and it was resolved to fund the cost of a Development Officer up to a maximum cost of £2500 until such time as there is a decision as to whether the County Council grant can fund this appointment.

#### Police Commissioner's Fund

The CDO reported that an invite had been received to make an application to the Police Commissioner's Fund for grant funding. **Resolved** to make an application for the provision of CCTV at Cross Hands Park to attempt to resolve the on-going vandalism at this location.

#### Lounge Improvements

The CDO outlined that the majority of the improvements to the lounge had been completed. Members expressed concern regarding the poor quality of the lighting in the room and suggested that this needs to be improved. The CDO reported that the Council is investigating an option for the lighting to be renewed as part of a scheme

### Lounge Improvements

The CDO outlined that the majority of the improvements to the lounge had been completed. Members expressed concern regarding the poor quality of the lighting in the room and suggested that this needs to be improved. The CDO reported that the Council is investigating an option for the lighting to be renewed as part of a scheme linked to the transfer of the electricity provider. **Resolved** to authorise the instruction of a local contractor to improve the lighting in the event that the alternative funding is not realised.

### Alarm System

A report was provided on a problem with the alarm system at Tumble Hall going off late at night. It was noted that it is inappropriate for an individual to have to enter the hall late at night where it is suspected that someone may have broken in. It was agreed that it would be appropriate to upgrade the CCTV system such that it would be possible to view the CCTV cameras on either a computer or a phone as opposed to staff having to enter the premises.
